2.0 PROPOSED PLAN CHANGE 22 – HERITAGE TREES

The Graduate Policy Planner Paul Harrington joined the meeting and presented the report which updated the Committee on the progress of Proposed Plan Change 22 (Heritage Trees) and sought the Committees recommendation to Council to publicly notify the Proposed Plan Change 22.

After discussion the Committee decided not to include the following four trees in appendix 2 of the Nelson Resource Management Plan:

- 41A Halifax Street (Orange, Landscape 123)
- 30 Stansell Avenue (Lime, Landscape 114)
- 18A Taupata Street (English Oak, Heritage 150)

It was agreed that these should be looked at for further consideration later in the year.

4.0 NOTIFICATION OF PROPOSED PLAN CHANGES 21, 19, 23, 24, 25 AND 26 TO THE NELSON RESOURCE MANAGEMENT PLAN

The Senior Policy Planner Debra Bradley joined the meeting and presented the report which sought the Committee's recommendation to Council to publicly notify the following proposed plan changes:

Plan Change 19 - Blackwood Street Reserve (West) rezoning

Plan Change 23 – Daylight

Plan Change 24 – Freshwater

Plan Change 25 - Technical fixes

Plan Change 26 – Fire fighting provisions

During discussion the question was raised whether Council has regional responsibility in addressing its stormwater runoff into its local streams. It was pointed out that the freshwater plan change was just a tidy up and the matter of stormwater would be coming back to the new Council by a report.

The Committee expressed its disappointment that the State of the Environment Report was overdue coming to Council and the report needed to come to the new Council as soon as possible and should include particular reference to address the urban stormwater issue.

5.0 RESIDENTIAL SUBDIVISION, LAND DEVELOPMENT MANUAL AND COMPREHENSIVE HOUSING – PLAN CHANGE 14
