7 Reports

7.1 NZ Transport Agency Waka Kotahi Update

Director Regional Relationships, NZTA Waka Kotahi, Emma Speight, presented a PowerPoint Presentation, which is available on the Council's website in the Minute Attachments Document.

Ms Speight answered questions around the new investment prioritisation tool and the relation to cost benefits, the Hope Bypass planning commencement date, the Emergency Works Policy review, speed limits, rotting trees on the roadside and Millers Acre bus hub access.

change the allowable weight of trucks on the Tākaka Hill road.

7.2 Public Transport Update

Team Leader – Transport Activity Management, Lyndon Hammond, spoke to the report and noted that not all the data was available when the report was written. Mr Hammond tabled two graphs that reflected the additional data, which are available on the Council's website in the Minute Attachments Document.

Nelson City Council Group Manager Infrastructure, Alec Louverdis and Mr Hammond answered questions.

Action: Lyndon Hammond to compile and circulate data to members on:

- passenger numbers in relation to half or full fare payment
- school holiday usage
- usage for school or other
- whether gold card users travelling free at off peak and peak times were tagged as super gold card users or adult fares
- patronage numbers from each bus stop/route and subsidies.

Mr Hammond confirmed that this data would be included in the upcoming review.
