7 REPORTS

7.1 Regional Pest Management Plan 2019 – 2029 Partial Review Consultation

Special Projects Analyst, Paul Sheldon, presented the report, and gave the background on the process so far, noting the engagement with sector groups and that, for most species, feedback had been positive.

It was noted that a cats bylaw process was underway in Tasman and Nelson would be providing options on a bylaw in April 2024.

Questions and discussion took place including what was allowed under biosecurity legislation, the Management Plan review schedule and pest agent rules and enforcement. In response to a suggestion for Tasman-wide requirements in the Plan for cat microchipping and desexing, staff recommended a combination of approaches using the Cat Bylaw and the Regional Pest Management Plan 2019 – 2029, as proposed.
