#### 7 REPORTS

#### 7.1 Saxton Field Activity Update

Parks and Facilities Asset Planner, Jane Loughnan, updated the committee on the following:

- a poster sized hard copy of the development plan was available if the Committee wanted to view it after the meeting
- work on the sand storage area in section 3.21 was set to start in the following weeks and was scheduled to be completed this financial year
- the driveway sealing would happen next financial year, due to weather conditions
- the Saxton culvert upgrade in the compound area on Main Road Stoke had now been closed, however the storage area near the archery behind the athletics area was hoped to be remediated in July 2024, but would be more towards the next financial year
- a correction was noted the Masters Games -Track and Field.
- Saxton Field would be the registration site for the Spring Challenge in September and was now being advertised for the annual Nelson half marathon in November 2024.

Ms Loughnan also noted that the actions table at the end of the agenda, would only address the active actions going forward.

#### 7.2 Saxton Field Long Term Plan Submissions

Reserves Officer, Rob Coleman, took the report as read and noted the considerable increase in the LTP submissions this year compared with previous years.

The changes to the report were as follows:

- Netball Surface Renewal bring forward \$27,500 of the total surface renewal budget (\$211,356) from 2027/28 to 2024/25 to fund 50% of the feasibility study for the proposed netball court roof
- Play Facilities bring forward \$15,000 budget from 2028/29 to 2024/25
- Play Facilities bring forward \$250,000 budget from 2029/30 to 2026/27
- Harakeke Green Irrigation and Subsurface Drainage defer the full budget from 2025/26 to year 2027/28
- Harakeke Green Cricket Wicket Blocks defer the full budget from 2026/27 to 2028/29
- Saxton Entrance Development defer the full budget from 2024/25 to 2026/27
- Baseball Diamond move \$100,000 from the baseball diamond budget from 2024/25 to the play facilities budget in 2025/26

Mr Coleman noted the remaining baseball budget would be to provide structures at Champion Green.

The meeting was adjourned at 10.17am.

Councillor Tim Skinner and Group Manager Infrastructure, Richard Kirby, left the meeting.

The meeting was reconvened at 10.26am.

Ms Loughnan spoke about the submission for a multi-use beach sport facility, she noted the aim was to work with the submitter regarding a location and feasibility.

Mr White noted that the artificial turf was a conversation at a recent workshop. He said that staff would await the outcome of the LTP deliberations and agreed there was more work to be done, however there was strong support for continuing the programme of works for lighting and drainage.
